**ORDER IMPOSING DISCIPLINE UPON
ERIC JIMENEZ**

Pursuant to General Order 96-05 (as amended) of the United States Bankruptcy Court for the Central District of California, and based on the Memorandum of Decision entered by the hearing panel in this matter concurrently with this Order,

IT IS ORDERED as follows:

1. Eric A. Jimenez ("Jimenez") is hereby suspended from the practice of law before the United States Bankruptcy Court for the Central District of California as of October 31, 2011.
2. Jimenez must substitute out of all of his cases currently pending before the United States Bankruptcy Court for the Central District of California. Jimenez must immediately advise all of his clients that he has been suspended from practice before this court and assist in the transfer of all records for those cases.

1 3. Jimenez's log in information for the ECF System must be de-activated by the Clerk
2 of the Court and not reactivated unless and until Jimenez is reinstated.

3 4. After November 1, 2012, Jimenez may apply to the Chief Judge of this Court for
4 reinstatement to practice before the United States Bankruptcy Court of the Central District of
5 California, using the procedures set forth in General Order 96-05 (as amended), provided that he
6 has completed all of the following requirements: (a) twenty hours of continuing legal education on
7 the subject of bankruptcy law (of which at least ten hours must address consumer bankruptcy law),
8 (b) ten hours of continuing legal education on the subject of legal ethics and (c) ten hours of
9 continuing legal education on the subject of law office management.




