OVERBID PROCEDURE

In order for any party to participate in an overbid procedure regarding the acquisition of the Property, the Trustee requests that the parties comply with the following provisions:

a. Each party, including Madhava Yatham (the "Buyer"), interested in participating as an overbidder must appear at the hearing on the Motion or represented by an individual or individuals with the authority to participate in the overbid process (Please check the Court's website at www.cacb.uscourts.gov for Judge Klein's instructions on appearing at the Sale hearing);

b. Each party participating in the overbid process (except for Buyer) must provide to the Trustee, a deposit in the form of a cashier's check made payable to "Jason M. Rund, Chapter 7 Trustee" in the amount of \$20,000.00 (the "Deposit"). The Deposit shall not be refundable if such party is the successful bidder and is thereafter unable to complete the purchase of the Property for any reason other than a material breach by Trustee. Each party participating in the overbid process (except for Buyer) must also provide the Trustee with evidence of the financial wherewithal to close the contemplated sale;

c. Subject to Court approval, the Trustee recommends that subsequent bids be tendered in increments of at least \$10,000.00, such that the next bid, if a party tenders an initial overbid of \$150,000, would be \$160,000.00;and

d. Each party (including the Buyer) must pay the full amount of the successful bid to the Trustee within the time period set forth in the Settlement Agreement or otherwise within sixty (60) days from the date of the Order approving the Motion becomes a final order, whichever is earlier. In the event that the Buyer is not the successful bidder of the Property, the successful bidder shall then become the buyer under the same terms and conditions as set forth in the escrow documents. Furthermore, if the successful bidder cannot deliver the balance of the sale price within the above-referenced period, the successful bidder's deposit shall become non-refundable.
