- any initial overbid for an assignment of the Estate's interest in the Vehicles (a) must be in an amount at least \$1,000 greater than the amount to be paid by the Debtor under the Agreement (i.e., in an amount not less than \$9,600.00 plus the amount of the Debtor's \$3,625 exemption in the Rav4 for a total of \$13,225);
