Developed with input from various bar associations, focus groups, and the public, the Committee gathered, reviewed, and incorporated feedback and suggestions. Judge Klein's legal career, shaped by diverse experiences, underscores her commitment to justice and education. After earning a bachelor's degree in music education, Judge Klein pursued a Juris Doctor at Loyola Law School, leading to her judicial clerkships, an associate position in private practice, and various roles with the U.S. Department of Justice. Her innovative efforts include producing "Stop Identity Theft Now," a pioneering public service video addressing identity theft. On the bench, Judge Klein enjoys the dynamic nature of bankruptcy law, which she describes as "a big umbrella of different areas of the law that come into play."

Beyond the courtroom, Judge Klein actively invests in community and youth engagement. Judge Klein initiated programs like the Girl Scouts' Justice Patch and mock trials for students, aimed at demystifying the legal system and inspiring future generations. "It's just really important for them to see how the judicial process works," she states, underscoring the importance of fostering trust and understanding in the community. Her mentorship extends to law students and externs, whom she guides in learning about judicial decision-making, with former extern Jason Treul describing her as instrumental in his development. Through her professional and volunteer efforts, Judge Klein exemplifies a judge deeply committed to fairness, education, and giving back to society.

#### **COURT PUBLISHES 2023 ANNUAL REPORT**

The Court marks each year with the publication of its annual report, which records the year's achievements and challenges. In December, the Court published the 2023 Annual Report. The report details the Court's ongoing efforts to improve service and extend access to justice through technological innovation, participation in national and regional initiatives, and community outreach.

Some of the notable accomplishments and achievements include: hosting the 2023 NCBC Conference in Anaheim; upgrading the infrastructure and courtroom technologies throughout the district; launching a new web-based mediation program; participating in the AO's 2023-2024 Model Intern Program; conducting workshops and presentations for aspiring judges, new attorneys, law clerks, and externs; continuing the Court's robust community outreach efforts; and the active participation of judges and court staff in numerous local, circuit, and national events, while providing exemplary service.

## BANKRUPTCY FRAUD PROSECUTIONS

The following information has been provided by the Office of the United States Trustee:

### United States Trustee v. Nasir Mahmood Cheema; USBC Case No. 6:23-ap-01088-RB

Nasir Mahmood Cheema filed for Chapter 7 bankruptcy protection on November 18, 2022 (the first chapter 7). Debtor listed a home in Fontana with \$402,189 of equity, a 2020 Honda Accord with no equity, various personal and household items, and cash totaling \$3,670. The non-priority unsecured debt totaled \$849,650.16, which included a judgment of \$600,400.16 entered by the Arizona Superior Court, County of Mariposa on May 5, 2022. Debtor did not list any gifts given or transfers made within 2 years of filing and claimed no affiliation to any businesses. Debtor did not appear at any of the three noticed 341(a) meetings and the proceeding was dismissed.

On July 14, 2023 Cheema filed a second chapter 7 petition using the same petition, schedules and statements as in the first chapter 7 proceeding. An investigation conducted by the United States Trustee revealed that in early 2022 debtor had transferred ownership of his primary residence to his adult children as a gift with no consideration, despite having approximately \$400,000 in equity. Shortly thereafter debtor instructed his children to transfer the property back to him. Debtor authorized the sale of real property in Nevada as President and Treasurer of a Nevada corporation in May 2022 and received \$165,375 in net sale proceeds, which he spent on discretionary purchases, and \$20,000 gifts to each of his three children. When questioned by the chapter 7 trustee, the debtor admitted that he has engaged in these transactions because his creditors sued him and obtained a \$600,000 judgment. The chapter 7 trustee has filed a notice of assets and will be pursue administration of the estate.

On August 21, 2023, the United States Trustee filed an adversary proceeding to deny debtor's discharge pursuant to 11 U.S.C. §§ 727(a)(2), (a)(4) & (a)(5). On December 16, 2024, the United States Trustee obtained a stipulation with debtor for entry of judgment in favor of the United States Trustee pursuant to 11 U.S.C. § 727(a)(10). An order granting the stipulation was entered on December 17, 2024.


